

Competition Terms and Conditions

The Promotion

Whitsunday Regional Council the 'Promoter' is running a Promotion where the following prize pool is available to WIN:

- 5 x two-person economy seats on Bonza Airlines from Whitsunday Coast Airport to Toowoomba Wellcamp departing Friday 21 April 2023 (Flight Number AB1411) returning Monday 23 April 2023 (Flight Number AB1412) including 23kg checked luggage.

(Total Prize Pool \$905)

The flights have been donated by Bonza Airlines and does not include accommodation at the destination or spending money. Flights must be redeemed by 5:00pm AEST Wednesday 19 April 2023.

Who Can Enter

Entry is open to Queensland residents, aged 18 years of age or older except for employees and immediate family members of the Promoter.

Immediate family referenced in these terms and conditions refer to spouses, de facto spouses, children or step-children (whether natural or by adoption).

The Promoter reserves the right to request the Winner to provide proof of identity, proof of residency within Queensland at the nominated prize delivery address and/or proof of entry validity in order to claim the Prize.

Determination and Notification of Winner

General
